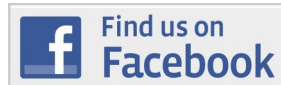

If you plan to have guest(s) use our facilities, please advise them that we will ask for their name and address. **Members must remain with their guests at all times.** Guests may not use the Clubhouse or any part of the facility alone.

Membership ID cards will be required for entry to the pool parties! Valid proof of age (driver's license or state id) is required for those 21 or over who wish to

consume alcohol at the pool parties.

To use the Clubhouse amenities, you must have a current membership ID card and your dues must be up to date.

IF YOU HAVE AN OUTSTANDING BALANCE ON YOUR ACCOUNT, PLEASE CLEAR IT UP BEFORE THE POOL SEASON BEGINS, SO YOU DON'T MISS ANY OF THE SUMMER FUN!

Pool Operating Information



Open Swim—All members may swim.

Family/Adult—All members may swim but children age 12 and under (white and red membership cards) must be accompanied by an adult member of the Club or adult registered babysitter.

The Village IV pool will open during scheduled operating hours after the air temperature reaches 68° F. The pool will close during dangerous weather conditions such as: thunder, lightning and/or tornado watch as reported by the National Weather Forecast Service or by Clubhouse/Pool Management. **During dangerous weather conditions, everyone must exit the pool and pool deck area.**

The pool will re-open as soon as deemed safe by the Clubhouse/Pool Management in accordance with the Health Department Regulations.

Two lifeguards must be on duty at all times. **Pool hours may vary**

during late Summer Season. Please consult your monthly newsletter or call the Clubhouse for information.

Pool Rental—The pit area can be rented for parties Monday thru Thursday (5:00 PM–8:00 PM). Please remember the pool must remain open to members and their guests. Please contact the Clubhouse Office (630.960.2850) for additional information.

Locker Rental—Members holding blue and orange cards can rent a locker for the pool season. The cost is \$5.00 and a rental agreement must be signed. Village IV will provide the locks. Only 50% of the lockers are available for rental.

FOR THE PURPOSE OF SUPPORTING NON-SWIMMERS: INNER TUBES, WATER WINGS, AND ALL OTHER FLOTATION DEVICES ARE NOT PERMITTED AT ANY TIME. FOR SAFETY PURPOSES, ONLY A LIFE VEST APPROVED BY THE UNITED STATES COAST GUARD IS TO BE USED. IF A NON-SWIMMER USES SUCH LIFE VEST, A PARENT OR GUARDIAN MUST MAINTAIN DIRECT SUPERVISORY CONTACT WITH THE NON-SWIMMER AT ALL TIMES.

If your children are not swimmers, please consider purchasing a **US COAST GUARD APPROVED** life vest or puddle jumper. These can be purchased at Wal-mart, Target or sporting goods stores. They are also available online at amazon.com:

Court Rules & Regulations



Please review the court rules and regulations and contact the business office Monday thru Friday (9:00 AM - 5:00 PM) if you have any questions.

The courts are locked during non-playing times.

The key can be obtained from the business office.

As always, members must have their Membership ID card with them to use the facility and dues must be current.

A member with a delinquent account cannot use the facilities as a guest of another member.

The courts will be open during regular Village IV Clubhouse hours of operation. Playing time is limited to one hour. Playing time will begin and end on the hour. Players who arrive ten minutes after their starting time may lose their reserved court time. Members may reserve only one time slot per day.

Reservations can be made by phone or in person. (Optional)

Proper shoes and attire are required. Players must provide their own equipment. Only players are permitted on the court. Items not pertaining to play must be left outside the courts.

Food and beverages (except water) are prohibited on the courts at all times.

The only activities allowed on the courts are Basketball, Tennis and pickle ball.

A maximum of 12 people will be allowed on the Basketball court and 4 people on the Tennis Court (except during Village IV sponsored events, such as lessons).

All members and guests must register at the Clubhouse Office.



Pool Rules & Regulations

All members and their guests must obey the rules and regulations as set forth by the State of Illinois, County of DuPage and the Village IV Organization when using the Club's facilities.

Pool Rules and Regulations

- All persons using the pool do so at their own risk. The Village IV Organization will not assume responsibility for any illness, accident or injury suffered by anyone while in or about the pool area.
- All persons are required to take a shower with soap before entering the pool.
- The County and Health Department require that all children who are not toilet trained be required to wear tightly fitting disposable swim diapers. This rule will be strictly enforced.
- Bathers with shoulder length hair are required by the County Health Department to wear a bathing cap or have hair secured with rubber bands. Barrettes and bobby pins can not be used to hold hair back. Hair ties only.
- Street shoes are not to be worn on the pool deck. Clean pool shoes may be worn.
- Swim suits are the only attire permitted in the pool. White t-shirts may be worn if necessary. If cultural beliefs prohibit you from wearing traditional swim suits, please look into alternative modest swimwear. **Street clothes are not acceptable swim attire.**
- For personal safety no one is permitted to sit in the lifeguard's chair, hang, sit or stand on the safety buoy lines in the pool or use the safety equipment as a toy.
- Ladders are to be used for entering and exiting the pool only. **No prolonged standing, jumping or hanging on ladders.**

Pool Rules & Regulations—Continued

- Whenever additional safety or health rules are deemed necessary, the management reserves the right to implement rules as unique situations may arise. Management will notify the members and the Village IV Board of its actions by posting signs. The Board will then review and if agreed, approve the additional rules.
- Lifeguards are responsible for the pool and locker facilities under the direction of the Manager. **The judgment of the guards and management shall prevail as to proper dress, conduct, admission and all other pool matters.**
- Persons under the influence of alcohol /substance or exhibiting erratic behavior will not be permitted to enter the facility.
- The County of DuPage refuses admission to the pool to persons having any contagious diseases, infectious condition or abrasions, which have not healed.
- Parents/guardians and registered babysitters must be responsible for supervising their children. Lifeguards are on duty to enforce rules and respond in case of an emergency.
- Wet attire will not be permitted in the upstairs lounge, upstairs game area, weight room or on the fitness equipment. Proper attire is required to use the Clubhouse facility.
- The ramp entrance should be used for entering and exiting the pool area.
- The diving board will be available at designated times by the lifeguards on duty or management. Diving is permitted from deep end sides when board is closed and approved by guards.
- Floatation devices are not permitted from the diving board.
- Large floatation devices are not permitted in the pool without approval by Clubhouse Management.
- For safety reasons, the use of **snorkeling equipment is not allowed**. This includes fins, breathing tubes, vests and masks.
- Lockers are available in the locker room. Summer rental of the lockers is available. Members/guests must provide their own locks for daily rental. **Daily rental locks must be removed at the end of the day or lock will be cut off.** Items left behind will be stored for the season and then discarded.
- For personal safety, the County restricts running, pushing, and rowdy behavior on the pool deck, in the water or on the diving board. **Persons who persist in dangerous activity will be required to leave the pool and can lose Clubhouse privileges.**
- Food and drink will be allowed in the Pit and behind the blue lines. **Glass containers of any kind are prohibited.** Absolutely no food, beverage of any kind allowed in or by the pools edge.
- Members are required to clean up after themselves.
- **Smoking is not allowed in the pool area. Smoking is only allowed in the designated smoking area outside of the pool's main entrance.** (Change to smoking rule as of 2017 season).
- **NO PROLONGED BREATH HOLDING.**

Lounge Chair Regulations

- Lounge chairs are provided for Adults (Blue and Orange Cardholders) only on a first come, first serve basis. Children using lounge chairs are required to relinquish them when adults are present and in need of a chair.
- Lounge chairs are not to be moved into the pit area or outside of the pool area.
- **Lounge chairs are NOT permitted in the Kiddie Pool.**
- Members cannot reserve pool chairs with towels or other belongings and return later in the day.

Membership ID Cards

- Permanent Membership ID cards are issued to every member of the Organization living at home (including dependent children).
- **Members who are delinquent in assessments are not eligible to use the Clubhouse facilities (including the pool).**

Guest Policy

- Members must accompany any guest at all times. Members are responsible for the conduct of their guests.
- ID cards are published with guest(s) permitted per type of membership. Please refer to the back of your card for details.
- Primary Members (homeowners) who on occasion have more guests than allotted on their card may contact the Clubhouse Office in advance and secure additional guest passes per day, subject to pool capacity.
- In the event of overcrowding at the Village IV Pool, management reserves the right to amend the guest rules in order to alleviate the situation.
- **Guests must register with their name and address.**

Babysitter Rules For Children Under the Age of 10

- Children under the age of 10 may use the pool under the direct supervision of:
 - A sibling 16 years of age or older or
 - A non-member babysitter 18 years of age or older.

It is required that the member child's parent fill out a Babysitter Waiver Form, available at the Clubhouse office. It is strongly recommended that this form be filled out prior to the first day of the pool season. The completed form must be approved by Village IV staff in order to be valid.

Kiddie Pool

- The Kiddie Pool is reserved for children age 5 and under. All children must be accompanied by a parent, adult or registered babysitter.
- The County requires that all children who are not toilet trained must wear **tightly fitting disposable swim diapers.**

Adult Swim Rule

- Fifteen (15) minutes of each hour will be reserved for adult swim. Infants may swim in the shallow end of the pool during adult swim time only if held by the parent or adult.

Spa-Whirlpool & Sauna Facilities

- Children under the age of 13 are not permitted to use the spa-whirlpool and sauna facilities.
- Children ages 13 to 17 years of age (yellow cardholders) may use the spa-whirlpool and sauna facilities only if an adult member accompanies them.

Membership Cards, Temporary Cards and Guest Passes

- All requests for updates to membership cards, temporary cards, and guest passes are handled in the Clubhouse office. Avoid the summer rush, come to the clubhouse to update your card before the pool opens for the season!
